**Admission Profile:** Individuals who experience physical, mental or emotional problems due to withdrawal from alcohol or other drugs, Individuals held under apprehend and hold orders under MN Statutes, Section 253B.07, Subdivision 2B, Individuals who have been committed under MN Statutes, Chapter 23B and in need of temporary placement, Individuals who are under emergency holds or Peace or Health Officer holds pursuant to MN Statute Section 256G.02, Subdivision 4, Individuals who need to stay temporarily in a protective environment because of a chemical dependency crisis and Individuals who meet the criteria on the PAI Detox Center Triage Plan.
